Terms and Conditions

Please ensure you read the competition rules as set out in the following terms and conditions. Entry into the competition will be taken to mean you agree to these rules.

1. The competition is open to all except for professional photographers & members of the Littleport Society Committee & their families.

2. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry that all terms and conditions are adhered to. Submission of an entry will be taken to mean acceptance of these terms and conditions.

3. The judges' decisions (whether in relation to determining any shortlists, runners up, or winners) are final. No correspondence will be entered into regarding such decisions.

4. Image files (from both digital cameras and smartphones) should be jpg (max. 10mb) and must be of a resolution suitable for printing to A4 size. One image only may be submitted. The image must be accompanied by a separate entry form. Entrants must supply on the entry form their name, email address and where the image was taken.

5. All entries must be received by 11:59pm on Friday, 10th May 2019. Late, incomplete or corrupt entries will not be accepted.

6. Entrants under the age of 16 must obtain the consent of a parent or guardian prior to submitting any images.

7. All images submitted must be the work of the individual submitting them and must not have been published elsewhere (excluding social media) or have won a prize in any other photographic competition.

8. All images entered must be taken in Littleport parish.

10. It is the responsibility of each entrant to ensure that the image they submit has been taken with the consent (or consent of a parent/ guardian if the subject is under the age of 18) of anyone who is identifiable.

11. Entrants must ensure that the photograph they are submitting is their own work, that they own the copyright for it and that it does not infringe the copyright or other rights of any third party or any laws.

12. Entrants will retain copyright and moral rights in their submitted image however, by entering, all entrants:

(a) grant The Littleport Society non-exclusive rights to use the image, if chosen, at their Heritage Weekend 2019 for exhibition purposes along with entrant's name and place location only.

(b) grant The Littleport Society non-exclusive rights to use the image to promote the competition the image was submitted to or for similar future competitions within a five-year period of the winner of the competition being announced;

(c) agree that the uses referred to at Clauses 12(a) and 12(b) above may include publishing, displaying or otherwise reproducing the image (whether on the internet, in The Littleport Society Magazine, in exhibitions or otherwise) provided such use is for the purposes of promoting the competition or similar future competitions only; and

(d) agree that The Littleport Society may contact them using the contact details provided to discuss potential use of the image beyond promotion of the competition. Such discussion and negotiation will be independent from the competition and will not affect entrants' chances of winning.

(e) agree that The Littleport Society can use the image non-commercially on its social media and in press releases for the promotion of future events.

13. The Littleport Society will endeavour to credit the photographer whenever his or her image is used and published by The Littleport Society.

14. The winner and two runners-up will be notified by 20th May 2019. If a winner cannot be contacted or is not available, The Littleport Society reserves the right to select the first runner-up from the remaining shortlisted entries as the winner.

15. The overall winner of the competition will receive a ± 30 cash prize. Two runners-up will receive ± 10 each. The prizes as described are available on the date of publication.

16. The winner and runners-up may be required to take part in publicity and their name may be published on The Littleport Society website, Facebook page and other Littleport Society publications, as well as any wider media reporting on the competition.

17. Events may occur that render the competition itself or the awarding of the prizes impossible due to reasons beyond the control of The Littleport Society and accordingly The Littleport Society may at its absolute discretion vary or amend the promotion and the entrant agrees that no liability shall attach to the promoter as a result thereof.

18. English law applies and the exclusive jurisdiction of the English Courts shall prevail.
